

WINGSTOP FLAVOR MADNESS SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The Wingstop Flavor Madness Sweepstakes (“Sweepstakes”) is sponsored by Wingstop Restaurants Inc., (“Sponsor”) 5501 LBJ Freeway, 5th Floor, Dallas, TX 75240 and is administered by Prize Logic, LLC (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI USA 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 17, 2019 at 12:00:00 PM Eastern Time (“ET”) and ends on April 9, 2019 at 11:59:59 PM ET (“Sweepstakes Period”) and consists of twenty-four (24) daily entry periods (each a “Daily Entry Period”), as outlined in the chart below, and one (1) grand prize drawing (“Grand Prize Drawing”) that runs the entire length of the Sweepstakes Period:

Non-winning Daily Entry Period entries will carry-over into subsequent Daily Entry Period drawings. All entries will be in the Grand Prize Drawing. The Administrator’s computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia, who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, affiliated agencies & Wingstop Franchisees, and each of their respective parent companies, subsidiaries, affiliates, officers, governors, owners, distributors, retailers, advertising and promotion agencies, and companies involved in the implementation and execution of the Sweepstakes (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address. Winning a prize is contingent upon fulfilling all requirement set forth herein. Entrants and/or potential winner may be required to provide proof of identification and eligibility as required by Sponsor or Administrator.

- 3. HOW TO ENTER THE SWEEPSTAKES:** There are two (2) ways to enter the Sweepstakes:
- A. Make a Purchase:** During the Sweepstakes Period, an eligible entrant may purchase any item online at Wingstop.com (“Qualifying Purchase”), while supplies last. Entrants who make a Qualifying Purchase will receive a code (“Code”) and an order confirmation number (“Order Confirmation Number”) on the order confirmation page (Code and Order Confirmation Number will be e-mailed to entrant as well). Entrant must then visit www.wingstopflavormadness.com (“Website”) and complete and submit the registration form including, but not limited to: his/her first

and complete last name (no initials), phone number, street address (no P.O. Boxes will be allowed), city, state, zip code, date of birth, Code, Qualifying Purchase Order Confirmation Number and agreement to these Official Rules. Entrant must then follow the links and instructions to fill out the provided bracket (on first visit only). Upon approval of Order Confirmation Number and Code and completion of a bracket, an entrant will receive one (1) entry into the applicable Daily Entry Period and one (1) entry into the Grand Prize Drawing. There is a limit of one (1) entry per day during the Sweepstakes Period.

- B. Mail-In Without Making a Purchase:** To earn a Sweepstakes entry without making a purchase, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY), on a 3½"x5" card ("Mail-In Entry") and mail it (in an outer mailing envelope) with sufficient postage to The Wingstop Flavor Madness Sweepstakes, PO Box 251328, West Bloomfield, MI 48325. A Mail-In Entry is worth one (1) entry. An entrant may mail-in one (1) per day during the Sweepstakes Period. Following this method of entry, an entrant will receive one (1) entry into the applicable Daily Entry Period and one (1) entry into the Grand Prize Drawing.

All Mail-In Entries must be postmarked by and received by the date indicated in the chart above in Section 1. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Limit: Regardless of method of entry, an entrant will receive no more than one (1) entry per day during the Sweepstakes Period. If more than the stated number of entries are received from the same person, telephone number and/or e-mail address, the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may not be eligible to win a prize.

- 4. RANDOM DRAWING:** On or around April 22, 2019, the Administrator will randomly select one (1) potential grand prize winner from all eligible entries received during the Sweepstakes Period and twenty-four (24) potential first prize winners from all eligible entries received during each respective Daily Entry Period (one [1] per Daily Entry Period). On or around each respective drawing date indicated in the chart above in Section 1, the Administrator will randomly select one (1) potential second prize winner from all eligible entries received during each respective Daily Entry Period for a total of twenty-four (24) potential first prize winners and twenty-four (24) potential second prize winners. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
- 5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**

- A. Grand Prize (1):** The grand prize is a trip for two (2) to Atlanta, Georgia (“Grand Prize”). Trip includes round-trip, coach class air transportation for two (2) people (for winner and one [1] guest) from a major commercial airport near the winner’s residence (as determined by Sponsor at its sole discretion) to the airport closest to Atlanta, Georgia, two (2) nights hotel standard accommodations (one [1] standard room/double occupancy pending availability), a one (1) Ticketmaster® Gift Card that equals two thousand dollars (\$2,000) (“Gift Card”; see terms below in Section F) (for winner only), and a \$250 in spending money (for winner only), to be awarded in the form of a pre-paid debit/credit card. The card is not transferable, redeemable for cash or exchangeable for any other prize. The Sponsor is not responsible if any card is lost, stolen, destroyed or used without permission. If the card is lost or stolen, it will not be replaced. Winner’s guest must be eighteen (18) years old or older. If the winner elects to travel or partake in the Grand Prize without a guest, no additional compensation will be awarded to the winner. Winner must travel on April 5, 2020 and return on April 7, 2020 or the Grand Prize will be forfeited. Winner and guest must travel on the same itinerary. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the Grand Prize will not be awarded. If winner resides within a 100-mile radius of destination, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. Travel dates are subject to availability; blackout dates and other restrictions may apply. Winner and guest are responsible for having valid travel documents including government identification and/or passports. Winner will be required to provide a major credit card upon hotel check-in, and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of the winner. Sponsor bears no responsibility if any event, element or detail of a Grand Prize is canceled, postponed or becomes unavailable for any reason. Should any event, element or detail of the Grand Prize become unavailable, the Sponsor shall have no obligation to the winner aside from providing the remaining portion of the Grand Prize, minus any unavailable event, element or detail. Only one (1) Grand Prize is available in the Sweepstakes. The ARV of the Grand Prize is \$4,250.
- B. First Prizes (24; 1 per Daily Entry Period):** Each first prize is Wingstop Wings for one (1) year awarded in the form of a \$1,000 Wingstop gift card (each a “First Prize”). Only twenty-four (24) First Prizes are available in the Sweepstakes. The ARV of each First Prize is \$1,000. Terms and conditions of gift cards apply.
- C. Second Prizes (24; 1 per Daily Entry Period):** Each second prize is a Wingstop swag bag (includes branded blanket, tote, and mug) (each a “Second Prize”). Only twenty-four (24) Second Prizes are available in the Sweepstakes. The ARV of each Second Prize is \$50.
- D. Total ARV of All Prizes:** The total ARV of all prizes is: \$29,450.
- E. Odds of Winning:** The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.

- F. General Conditions:** In no event, will more than one (1) Grand Prize, twenty-four (24) First Prizes (one [1] per Daily Entry Period), and twenty-four (24) Second Prizes (one [1] per Daily Entry Period) be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. Limit: One (1) prize per person.

The Gift Card can be used for purchases online at www.ticketmaster.com, www.ticketmaster.ca, via Ticketmaster telephone lines and at participating authorized retail outlets and venue box offices. - 6. HOW TO CLAIM A PRIZE:** After the random drawing, Administrator will notify the potential winners via e-mail at the e-mail address provided at the time of registration or Mail-In Entry. Before being declared a winner, the potential Grand Prize winner will be required to sign and execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment ("Affidavit"). The potential Grand Prize winners must return a fully executed and notarized Affidavit to the Sponsor or its authorized designee within five (5) calendar days from the date it is postmarked as being sent to the potential winner or the Grand Prize may (in Sponsor's sole discretion) be forfeited.
